- 1. The meeting was called to order at 12:01 p.m. by Secretary Bill Jeffries.

Fiscal Officer Soza explained that \$153,769.72 was received into the General Fund from the sale of the Church Street house. She would like to request the Board transfer that money into the 21<sup>st</sup> Century Fund now so that she may have an accurate Alternative Tax Budget.

i. Alternative Tax Budget

In accordance with Ohio Revised Code, the library board must review and approve the 2025 Alternative Tax Budget (Appendix A) in July. Once approved, the Louisville City Schools Board of Education will approve this at their August Board meeting. After approval, the budget must be sent into the Stark County Auditor's office by August 20.

Fiscal Officer Soza presented the Alternative Tax Budget to the Board of Trustees. Secretary Jeffries suggested the principal and interest be separated on the report to the Auditor. Fiscal Officer Soza agreed and explained she has a phone call scheduled with the Auditor to discuss reporting requirements for borrowed monies.

R65-2024 Ms. Walton moved/Ms. Aljancic seconded a motion to approve the draft of the 2025 Alternative Tax Budget with the necessary changes as discussed. If the Stark County Auditor sends updated Property Tax Figures of PLF figures, this change will be reflected before it is sent to the LCS Board of Education for approval, if possible.
